### Section 3 - HAZARDS IDENTIFICATION

#### EMERGENCY OVERVIEW

The toxicological properties of this material have not been fully investigated.

Potential Health Effects

Eye:

May cause eye irritation.

Skin:

May cause skin irritation.

Ingestion:

May cause irritation of the digestive tract. The toxicological properties of this substance have not been fully investigated.

Inhalation:

May cause respiratory tract irritation. The toxicological properties of this substance have not been fully investigated.

Chronic:

May cause reproductive and fetal effects. Laboratory experiments have resulted in mutagenic effects.

Animal studies have reported the development of tumors.

#### **Section 4 - FIRST AID MEASURES**

#### **Section 5 - FIRE FIGHTING MEASURES**

General Information:
